In pursuance to the decision of the High-Power Committee taken in its meeting hold on dtd. 28-01-2022 read with approval of Govt. vide Letter No.11979 / SME, date 28-08-2020 and as per guidelines issued by the Government in the Department of School & Mass Education, Odisha, Bhubaneswar vide Resolution No. 30720/CME dtd. 23.09.96 read with G.O. No. 29519/SME dtd. 26.09.1998 **No objection certificate (NOC)** is hereby granted in favor of **St Xaviers Public School, At/Po/Ps/Dist- Boudh, Odisha** to open a Senior Secondary School up to **Class-XII** for the purpose of obtaining affiliation from the **CBSE** subject to the following terms and conditions.

1. The 'No objection Certificate' now issued shall be subject to the terms and condition as prescribed in the G.O No 30720-SME did 29.9.1996.
2. The Land is to be recorded in the name of institution and copy of the record of the rights to be furnished by the authority of the institutions within one year from the date of issue of the order.
3. Own building of the school should be completed as per the norms on its own land within one year.
4. Medium of instruction in the school shall be English but Oriya shall be taught as a subject to all pupils in the institution compulsory.
5. The school shall be open for the inspection by the inspection team.
6. No financial assistance and grant-in-aid (both recurring and non-recurring) will be claimed by the institution from the Govt. at any point of time for meeting the salary cost and its component towards teaching and non-teaching staff appointed by the managing committee.
7. The M.C of school will not shift the present location of the school without prior approval of Director, Secondary Education Orissa.
8. The untrained teachers will have to acquired training qualification within three years.
9. The high-power committee shall review the N.O.C granted to the institution concerned in the next HPC after elapse of one year and shall withdraw the same if the terms and conditions contained in the G.O No-30720/SME, did 23.9.96 is violated at any time.
10. The Managing Committee shall be constituted in accordance with the section-7 of the Odisha, Education Act-1969.
